# IF YOU ARE A CLASS MEMBER IN A CLASS ACTION LAWSUIT INVOLVING A COMPUTERTRAINING.COM OR COMPUTERTRAINING.EDU SCHOOL, RECENT EVENTS IN THE CLASS ACTION LAWSUIT MAY AFFECT YOUR RIGHTS

A court authorized this notice. This is not a solicitation from a lawyer. YOU ARE NOT BEING SUED.

You are receiving this notice because you are a Class Member in a class action lawsuit brought by former students of ComputerTraining.com and ComputerTraining.edu schools against ComputerTraining.com, ComputerTraining.edu, their parent company CTCI Corp, and their subsidiaries ("ComputerTraining"). The Class Action Lawsuit alleges claims for breach of contract, fraud, breach of fiduciary duty, and other claims as a result of the abrupt closure of all ComputerTraining Schools on December 31, 2009.

The purpose of this notice is to: (1) provide you an update on the status of the Class Action Lawsuit, (2) to explain the next steps in the lawsuit, and (3) to provide information about additional options that may be available to certain Class Members who financed their tuition through student loans.

#### 1. What is the status of the Class Action Lawsuit?

On November 22, 2011, the Court in charge of the Class Action Lawsuit entered a judgment in favor of all members of the Enrolled Class and the Graduate Class for the full amount of the tuition Class Members incurred at ComputerTraining, plus interest, including interest paid on any student loans used to finance the tuition at ComputerTraining.

## 2. What are the next steps in the Class Action Lawsuit?

The next steps will be for Class Counsel to determine whether there are any assets available to pay the judgment entered by the Court on November 22, 2011. ComputerTraining is defunct, and it is not known whether ComputerTraining has any assets available to pay claims of Class Members. Class Counsel are in the process of attempting to collect on this judgment through means available under the Federal Rules of Civil Procedure and other applicable laws and rules. There is no money available now, and no guarantee that there will be. If money or other benefits become available, you will be notified about how to ask for a share.

## 3. Are there additional options for those who financed their tuition through student loans?

Yes. Additional options for relief may be available for those students who financed their ComputerTraining tuition through a student loan through TFC Credit Corp, Sallie Mae, Inc., or another lender. Class Members who obtained student loans to pay their tuition may have additional means of obtaining relief by pursuing loan-related claims. Class Members who would like to learn more about a potential discharge of their loans and return of any funds paid under their loans may do so by submitting the enclosed loan information form by mail or email to the addresses on the form, or by completing an online form at <a href="https://www.ComputerTrainingClassAction.com">www.ComputerTrainingClassAction.com</a>.
